Job & Family Services of Clark County is seeking authorization of the following contracts:

### **OIC of Clark County**

In August of 2011 Job & Family Services of Clark County was awarded \$636,882. by the U.S. Department of Justice under the Second Chance Act Grant in order to provide reentry services to ex-offenders returning to Clark County for the period of October 1, 2011 through September 30, 2012. In addition, JFSCC has applied for a second year of funding through the Second Chance Act Grant in the amount of \$664,364.52. JFSCC is recommending approval of a contract with OIC of Clark County to provide reentry services for the period October 1, 2011 through September 30, 2013. The maximum amount of the contract is \$1,266,403.65. However, the second year of the contract will only be in effect pending JFSCC is awarded a second year of funding through the grant.
