He asked if paid administrative leave would continue for COVID once the vaccines are released to everyone. Staff planned to look at a cutoff date. Commissioner Lohnes noted sales tax was doing well. a downturn was not predicted. Tax collections are unknown at this point. Clark County's unemployment increased percentage wise but it is due to more people looking for a job. Discussion ensued about income tax.

There is conflicting information about the Recovery Act money. Staff was waiting on further guidance.

Commissioner Wilt reached out to ODNR (Ohio Department of Natural Resources) to request someone to speak to the Board about the proposed river designation. She also requested the Clark County Park District and NTPRD (National Trail Parks & Recreation District) speak about the merger. The Passenger Train Association may reach out to present to the Board.

County Administrator Updates:

Ms. Hutchinson arranged a meeting with CIC, Community & Economic Development and The City of New Carlisle for a meet and greet. It was a good meeting. She hoped to get partnerships and development in the New Carlisle area.

The strategic plan is finished. It will be posted on the website. She gave kudos to Mr. Cooper for his work on that.

Next week Commissioner Wilt, Mr. Harris and the Benefactor Group are doing an intro call for the fairgrounds strategic plan.

NTPRD/Park District has a tentative transition date of January 1, 2022.

Commissioner Wilt asked for the strategic plan to be shared with partners.

The Board reviewed the calendar.

Commissioner McGlothin asked for an update on the Clerk's office. Commissioner Wilt said verbally she committed to returning \$500,000 to the general fund. Her office needs to trigger the transfer. It hasn't occurred yet. Commissioner Wilt asked her to increase it to \$750,000 total. Ms. Tuttle said she would consider the additional \$250,000 in April.

The Municipal Court building is in the second week of demolition. Ms. Hutchinson said a second change order will be coming through. It is small, around \$450.

Audience Comments: Ms. Turner-Olinger was working with the county for permitting. She has been in contact with the county engineer for the storm water plan. They will not build any new structures. They own the next parcel closest to the houses on Tillie Lane. She wanted to work with the Commissioners to control that drainage. Commissioner Lohnes noted the former owners agreed to a swale. The Tillie Lane water comes from the east. The problem is funding. There were a number of houses to the north that were not impacted and did not want to contribute financially. Anything to dry up the corner would be appreciated by the owners of the farm as well. Commissioner Lohnes asked the EMA director to look into grant funding that might help with the Tillie Lane drainage project.

Staff Report: Mr. Neimayer gave the report. See attached. This location is the former bowling alley off of Gerlaugh Road and State Route 235. The property and surrounding area is a B3 district. This was submitted to be a machine shop operation. There are other uses that may or may not be appropriate for this zoning. The comprehensive plan states the area is mixed use low intensity. The request is appropriate. This property is not in the flood plain. This site was previously served by onsite utilities. There is public water and sewer at the intersection but it is quite a distance. Per the County Engineer's report storm water and access requirements need to be met. There are no proposed changes to the parking lot or building. Mr. Neimayer asked ODOT (Ohio Department of Transportation) about access since is a drive that on State Route 235. At that time when he contacted ODOT the end use was unknown. ODOT recommended a traffic study. Now that the end use is known, ODOT said there would be less traffic. Mr. Neimayer did not feel a traffic study would be warranted. Staff recommended approval with the following conditions: 1) All permitted uses shall be inside the building(s); 2) Allowing all I-1 uses except for the following: outdoor commercial recreations; adult entertainment establishments; 3) The end-user shall receive approval from the Health District, or Ohio EPA as applicable, for provision and treatment of water and wastewater systems; 4) The end-user shall receive approval from the County Engineer's office for storm water management as applicable; 5) Prior to approval/issuing a Zoning Certificate, the end-user shall receive approval from ODOT and the County Engineer's Office regarding access to the site. Rural Zoning changed the wording on item #5 to "approval from ODOT and/or the County Engineer."

Audience Comments: Mr. Lagos asked the Board to revise item #5 to say "approval from ODOT *or* the County Engineer". He felt the County Engineer's office was easily accessible and felt his approval was enough for this case. He thanked the Board for listening.

Commissioner Wilt asked Mr. Burns what type of manufacturing he did. Mr. Burns replied they support agriculture, aerospace and the military. She asked how the workforce was and if it was difficult finding machinists. Mr. Burns replied hiring is a challenge. Everyone is struggling for those talents. He partners with workforce development in Clark and Montgomery Counties.

Commissioner McGlothin asked if the access on State Route 235 was the driveway on the north side of Casey's. Mr. Lagos replied yes. Mr. Lago restated his confidence in the County Engineer. Mr. Burr knows what he is doing and has great skill. Mr. Lagos feared the State would hold up the project. If they required a traffic study it would cost money and time. Mr. Lagos wanted the decision to be kept local.

Commissioner Wilt asked Mr. Neimayer if they receive the County Engineer's approval does that create an issue. Mr. Neimayer responded Gerlaugh Road is the county's jurisdiction and State Route 235 is the ODOT's.

Mr. Lagos again asked for the change in wording. Commissioner Lohnes didn't see a big difference. He could support the requested change.

There being no one else in favor of or opposed to the proposed rezoning who wished to address the board, the Public Hearing was closed by the Commission President at 10:27 a.m.
